My Name

My Information Pack

For use in the event of my disability or death



The purpose of this document is peace of mind for the person completing it and to ease the burden for the surviving family. We all know that should we become incapacitated through illness or pass away that our family and loved ones will have administrative duties to undertake. These duties will be in addition to coping with our loss and the uncertainty that comes with this loss. These administrative duties are even more challenging and the uncertainties are even greater if we are not living in our mother country. This information pack, your pack, will provide peace of mind by greatly reducing the administrative burden for the family.

Over the last 30 years as a financial adviser, I have had many of these situations. Some have been clients, other cases have been where families of clients have passed away. After having had to advise and assist with the practical issues on too many cases, I know preparation is the best way to reduce both uncertainty for our loved ones and to ease the burden of the administrative obligations. In addition, preparation helps to ensure that only the correct amount of Inheritance Tax is paid and bank accounts, savings and pensions are not lost. By 2022 the UK government had taken more than £1 billion from bank accounts that had been dormant for 15 years and gave it to charities. Dormant pensions and savings will be treated in the same way shortly, and the figure for these has been estimated as exceeding £20 billion.

This record is designed to help with the many issues that people have to deal with following the disability or death of a close relative. It is comprehensive but cannot be exhaustive as each individual will have their own set of circumstances. However, it does include basic details which can often be overlooked at a time of stress and strain. Simple things can be hard to remember. Your partner's birthday and overlooking the notification of a death to a friend or family member are both examples I have seen of what stress and grief can do to a person. Another problem that often occurs is not knowing if there is a Will or if there is one, where the original is kept.

In the modern world of computers, social media and online banking it is passwords that cause considerable consternation. This problem can also be reduced with a little careful planning and I have included some information on this matter in your pack.

Before starting to complete your pack, it is recommended to read through the entire document to see what information is required. When completing the pack with your information, it may not be possible to find all the information at the same time. Anything you complete will help your family but the more you can complete the better. If you have to return to add further information later, you should view this as a normal part of the preparations that you are making, not as a problem. However, completing this pack will give you peace of mind that you have been well prepared and will make the administration a lot less painful for your family.

The pack not only provides the information that will be needed by the survivors to settle your estate, it can also be used as a checklist to ensure those that need notifying have been told or to confirm when an action has been completed.
